SWBT is proposing to renew Access Advantage Plus (AA+) Transport Service, a channelized DS1 High Capacity service, into SWBT's Access Service Tariff F.C.C. No. 73. AA+ Transport Service Contract Offering is available for one, two, and three- year terms during the purchase period which begins October 29, 2004 and ends April 29, 2005 with each term having its own contract number.

AA+ Transport Service is a dedicated transport service arrangement that integrates an end user's network access connections for multiple voice, data and other special access services onto a single interstate DS1 High Capacity Special Access Service. Further explanation of this contract offer is included in the attached Description and Justification.
