The SPNP Surcharge recovers the Telephone Company's costs directly related to providing long term number portability. It is billed on a monthly basis to all Telephone Company end users, including customers who purchase as unbundled network elements line-side switch ports and customers who purchase telecommunications services out of the Telephone Company's wholesale tariff (i.e., resale customers). This surcharge will be recovered over 60 months as listed in (F) following. (T)

The SPNP Surcharge will be applied on a per line basis with the following exceptions:

- PBX trunk customers will be assessed 9 monthly rates; and
- ISDN PRI customers will be assessed 5 monthly rates; and
- Lifeline customers shall not be assessed the SPNP fee.
